#### **PARK REGULATIONS**

#### HOURS – 8am to 7pm- no exceptions

- PARKING In designated areas only
- 2) FIRES Restricted to designated fire receptacles
- 3) **WEAPONS** Firearms and fireworks are absolutely prohibited, no exceptions
- 4) ANIMALS All animals are prohibited, no exceptions
- 5) **MUSIC** Live bands and audio amplification equipment is prohibited; personal radio/CD/MP3 music is permitted at reasonable volumes
- 6) SPEED LIMIT Maximum 5 MPH: registered vehicles may be driven on the pavement only
- 7) VEHICLES ATV's, mini-bikes and snowmobiles are prohibited except on designated authorized trails
